DELTA KAPPA ALPHA

Article I NAME

The name of this professional cinematography fraternity shall be DELTA KAPPA ALPHA representing the three principal branches of interest in Cinematography: That of the Dramatic (Delta), Cinematic (Kappa), and Aesthetic (Alpha) elements of the subject.

Article II PURPOSE

Delta Kappa Alpha, with the founding chapter at the University of Southern California, shall be for the purpose of fostering more effective dramatic, cinematic, and aesthetic interests in this rapidly advancing art and science of Cinematography, to encourage the dissipation and development of the possibilities, extent, and uses of Cinema as a means of expression, and to embody a

Article III MEMBERSHIP

Membership in Delta Kappa Alpha is limited to men. This restriction can only be amended, altered, or changed by unanimous vote of the CHARTER members. There can be NO exceptions to this article.

There shall be three general classes of members: (a) Active, (b) Associate, and (c) Honorary.

Active members shall be chosen from students of Cinematography at the University of Southern California. The students shall be of sophomore, junior, senior, or graduate standing in order to qualify for membership. This active chapter -- and others as admitted to the organization -- shall be limited to fifteen members. Qualified persons of other departments may be considered for membership -- their election shall be in accordance with the restriction

Associate members shall be chosen from members of the faculty of the University of Southern California, and from students who are active in Cinematography but are no longer enrolled in the University. Associate membership may be conferred upon Active Members upon graduation from the University or termination of university study.

Honorary Members. Upon the advice and consent of the members of this organization, individuals who are outstanding in the cinema industry (or allied fields of approved industry) shall be considered for membership and elected by proper procedure.

Article IV ELECTION TO AND
TERMINATION OF

Election to membership shall be by unanimous vote of the active members of the chapter of the fraternity.

New members shall be selected from approved students during the first six weeks of each semester of the school year. Their membership is subject to paragraph one of this article.

Chapter termination of pledge relationship or membership may be effected by proper procedure for a significant cause provided the member concerned is advised by written notice of the action and the due cause for same. Lack of attendance at chapter meetings shall be considered among the pertinent causes for dismissal from membership.

Cards of membership and a badge of association with Delta Kappa Alpha shall be available to members only.

Article V OFFICERS

The officers of this fraternity shall be (1) President, (2) Vice President, (3) Secretary, (4) Treasurer, and (5) Faculty Adviser. The first four stated shall be members of Delat Kappa Alpha in active standing and registered students of the

Student officers must be of junior or senior standing in order to hold office and shall be chosen by the active members of the chapter at the end of each semester for terms of the following session. Officers shall be eligible for reelection.

Article VI BY-LAWS & AMENDMENTS

By-laws may be adopted by the necessary and proper procedure on the part of the active members of the Alpha Chapter of Delta Kappa Alpha, provided they are accepted by two-thirds vote of these members.

Amendments to this constitution may be accepted and adopted provided two-thirds of the active members of the Alpha chapter shall approve of this action.

BY-LAWS:

Section I: Voting on pertinent issues shall be by secret ballot.

Section II: Meetings of the active chapter shall be at the discretion of the active members concerned with a minimum number of sessions being fifteen per semester.

Section III: Dues in Delta Kappa Alpha shall be one dollar (\$1.00) per semester.

Section IV: Assessments for this organization shall be arranged and provided to meet the needs of the active members during the period of necessity.

Section V: Initiation fees shall be sufficient amount to cover initiation, badge, and membership card.

Article VII CHARTERS

This organizing chapter of Delta Kappa Alpha shall be known as the Alpha chapter, and other chapters shall be specified as Beta, Delta, etc. in accordance with their admission to this fraternity.
