Allen suggested the production of a 35mm film on sound. The cost to be borne by 20 people at \$5 per person from those interested. Equipment and positive film to be furnished.

Present: Turner, Rodgers, Findlater, Dallas, Tarleton, Bissinger,

Bissinger gave a report on proposed financing of pledges. The question arose as to wheter to have pins for members and keys for pledges. Vote taken and idea as originally proposed by Bissinger was adopted i.e. to have members and pledges both have pins.

Tarlton called upon for pledge rules which were to be due thismeeting. Tarlton reported rules uncompleted but promised to present them at next meeting.

Next discussed question of ceremony for pledges as at which time they shall be formally accepted into the fraternity. Turner suggested a ceremony inwhich pledges would be questioned as if questions came from cameraman, director, etc. each with a question or so pertaining to that particular subject or field. No votetaken.

About foreign students—whether to have them or not. Undecided, so Bissinger was delegated to look into the matter and find the rules adopted by other fratermities regarding this question.

Pledge to-be-Hollowell, Stoddard, and Brousesau all discussed as their willingness to join. Rodgers stated that he contacted Hollowell who consented. Halpern says Stoddard in favor. Tarlton stated Brosseau was interested.

March 26, 1936-brief chapel session

Bissinger brought propose additiones to and changes in the by-laws. Were commented on and suggested changes made by the group.

Those Present were -- Bissinger, Dallas, Findlater, Halpern, Rodgers, and Mc Lelland.

Discussed advisability of asking Jack Warner to joined fraternity. Also Mr. Neil. The matter was held up until next dime due to short session. Prospective members Brousseau, Stoddard, and Wong were also mentioned but to be decided upon next time. A definite time was to be arranged for meetings and all members were advised to look up their schedules tofind a convenient meeting time. Meeting adjourned 10.30

Meeting opened with announcement by Mr. Dallas the the fraternity pins as ordiered had been shipped from Attleboro and would be available soon.

Members owing balances were urged to pay up.

Robert Rogers, then suggested report on new members. William Halpern motioned that Hugh Stoddard be elected to membership. Motion was carried. Raphael Brousseau was nominated by Louis Tarleton and this new candidate was duly elected. Richard Meil was elected on the motioned of Allan Dllas. The case of Mr. Wong was not voted on pending investigation as to his elegibility for membership.

The secretary was instructed to write a letter to each of the prospective members inviting them formally to join DKA.

Meeting was dismissed and the next meeting set for Thursday, April 2, at Chapel hour.

A definite time for meetings to be held hereafter was the first question discussed. After considering the best time it was decided to meet at 2:30 on Tuesdays every week thereafter and from this date.

Fraternity cards were discussed. The price as quoted for cards was found prohibitive at this time.

Dallas brought a copy of suggestions for pledge pins. It was decided by the group to adopt one which pictured, or was the impression, of a small 16mm reel, to be worm during pledgeship.

Convening to acquaint the pledges with the active members, Delta Kappa Alpha, cinematography fraternity will meet in 310 Bridge hall at 2:30 o'clock this afternoon.

Robert Turner will address the group on "Effective Flat Lighting" and Allen Dallas, Jack Findlater and William Malbern will present several films.

Rodgers called themseting to onder at 2.35. A story written by Terry
Bissinger was announced and proposed as sutiable for an 8 mm project for
the fraternity. Dallas gave a review of the story to give fraternity
and idea of the proposed film. Comments and suggestions were mede.

Story to be gone over by a group to be appointed and finally completed
to be handed in following Friday.

Discussed Commencement of actual shooting of film. Dallas, Neil,

Jack Findlater was appointed cameraman with Hugh Stoddard as assistent.

Mr. Brousseau showed a series of color pictures which were commented upon favorably by the group. Pledge Neil appointed to give an oral report on some phase of the industry. Stoddard was appointed to the task of providing films for next meeting.

Meeting opened with Bob Rodgers speaking to pledges on the aims and proposed schedule of the organization. Allen Dallas was in turned introduced at which time he expalined the purposes in more detail, extending a formal invitation, gave brief history of DKA, and what would be expected of the pleges.

Next a film was presented by Jack W Findlater titled "A Day in the

Mr. Dallas presented an 8mm film entitled "Ivy Dy" which depicted the proceedings of that day at the University of Nebraska. This film was received favoably with comment onthe good exposure obtained in spite of adverse climatic conditions.

The president then introuduce Mr. Robert Turner who delivered an interesting short talk on lighting—especially flat lighting with which he had experimented and found satisfactory. He illustrated his lectures with blackboard diagrams and with examples of photographs taken under varying conditions of light. The talk was interesting and all added something definite therefrom to their general knowledge. Iedgemaster Tarleton assigned Pledge Brousseau with the duty of providing entertainment at the next meeting. Treasurer Halpern collected from pledges. Meeting adjourned.

Bissinger read the script of the fraternity film as revised, according to suggestions made at previous meetings. Final checks made and to be finished and handed in a next meeting by Bissinger.

Due to the lack of time and the newness of the organization Dallas suggested that the rules regarding pledges by disregard this once and adopt the pledges into the fraternity as full fledge members. This was agreed upon by all those present as the best plan to be adopted to alleviate the condition.

Rodgers called meeting to orders.

Present: Bissinger, Halpern, Findlater, Mc Clleland, Stoddard, Neal, Tarletion, Fisher, Rodgers, Dallas.

Mc Clelland reported on Mr. Toland of United Artists. He said that Mr. Toland and he had discussed the fratennity and that he was definitely interested. Mc Clelland to get more details.

Next discussed matter of financing new 8mm film to be finished before semester ends. All agreed to contribute 50¢ which amply covered the purchase of the film with the discount. The script was carefully read, suggestions made and finally okayed. Plans were made to defintely start production and date set. Halpern collected \$3.50 on film. Friday set as dead line for cash to be turned in.

Pledge Stoddard then projected a film made by himself concering the lumbering industry. Favorably commented upon by the group.

Dallas then discussed the prospective film, what was planned, the proceedure, and just when the group would have to meet in order to finish the picture before the semester ends.

The meeting was opened with the projection of the fraternity film at least the amount which had been completed. Comments were made, mainly that there had been too many retakes. Bissinger showed a sample color film which was commented up favorably.

The meeting was opened by the introduction to the members of Richard Bare, by Dr. Morkovin. Mr. Bare was looking over the members of the frateinity in an effort to find those who would be interested in joining his new organization designated as Security Pictures with headquarters at Carmel-by-the-Sea. Various questions were ask by the members concerning the prospects of the company. Dallas ask several pertinent questions which were not answered satisfactorily, apparently. Both Dr. Morkovin and Mr. Dallas inquired as to the duties, remuneration. and opportunities which the new organization would present. These were answered indirectly by Mr. Bare. Dr. Morkovin summed up the propostion and gave a short talk concerning the fraternity, lauding their purposes, etc. and offering at the same time to entertain the group at his home some evening or afternoon convenient to the members, at which time he said he intended to invites everal men connected withthe industry.

After Mr. Bare and Mr. Morkovin left the meeting proper started—

A discussion was next held concerning the position of the faculty adviser. It was found that Dr. Morkovin was the faculty adviser but that such faculty advisers were not to have a part in the meetings. They could make suggestions, but these suggestion need not be heeded.

The balance of the meeting was taken up with the discussion of Mr. Bare's proposition as described above. Many flaws, especially as to financing the proposition were noted.

The President appointed a committee of three to get programs for the first month, during which there will be two meetings. The committee: Volger, Hollowell, Bailey.

Tarletone wants comtact with the Daily Trojan so we can get a lot of big publicity. He then read the constitution. He also wants to make a 16mm. short to show before the Trojan Review is projected, this to give the fraternity good advertising and experience.

Neal thought this to be a good idea but asked what kind of story would bwe use. McClelland suggested the work of various Departments on the campus but Neal wanted something more colorful. Tarleton wanted everyboyd to think about it, and suggested sports. Bailey suggested the story of the freshman from a greeny to the takk first football team. Two general opinions came from the group: nuts and lousy.

Discuss 16mm Short at Next Meeting

The News Retl was next discussed, Tarleton wanting everyone to work hard and offer suggestions. Herzberg, Tarleton, and Yarnell are the heads of its organization. Dick Neal asked what interest the Fraternity had in it and was told that they sponsered and were responsible for it jointly with the Department of Cinematography. In this way everyone is given an opportunity. Tarleton suggested putting the letters DKA after the members names who worked for it. He cautioned us not to forget to look for important coming events.

Ellis issued a call for experienced workers for the New Reel and Tarleton added that unqualified students were not wanted. The first 100 ft. of film has been returned from the processors and is good. Rodgers suggested that definite idea of how to shoot a scene be decided upon before starting the camera, and Ellis said that a script girl and director were assigned to each unit. Tarleton told of the sound effects to be used and thought it especially good for the Phi Taus eating soup -- tchsppshi.

Cinematography Student Wins Award For Travel Film

Ellis Yarnell, senior in the department of cinematography, received second prize in the international contest for amateur photographers conducted by the American Society of Cinematographers. The film submitted by Yarnell was taken this summer while he was official photographer for the Massachusetts Institute of Technology on its tour

of Europe.

The picture, to be presented in assembly Friday, is titled "Europa Touring" and covers only Denmark, Sweden, and Norway. The original film is in three reels but only one

of these was submitted.

Yarnell left school in May and sailed from New York on the Statendam on June 4. He arrived in Rotterdam eight days later. Here the party began its tour in a large truck in which chairs were placed in the daytime and to which beds were attached at night. The party did its own cooking.

Everywhere the stores were very small and had difficulty in supplying the amount of food the party needed. There were no large markets such as there are in America. Most of the stores are a part of the owner's home.

Natives Amazed

The natives were amazed at the amount of milk drunk by the group. Everywhere there was great interest in the truck, and crowds gathered wherever the party stopped. Often the mayor of the town came out to welcome the students. The utmost friendliness and courtesy were shown the group by all the persons with whom they came in contact.

Several days were spent in Paris. The Paris exposition was visited but it was quite incomplete at that time. All the usual art galleries and museums were visited as well as the Eiffel tower and the "Arc de Triomphe."

The party arrived in Munich the latter part of June. The point of greatest interest was the Deutsches museum, the largest scientific museum in the world. Here there is reproduced a complete full size coal mine, and all the famous scientific laboratories of history.

Beaches Visited

Norway Beautiful

The scenery of Norway was the most beautiful seen on the tour. The road taken went directly across the entire country and was very mountainous. The altitude remained close to 10,000 feet. There were many waterfalls and rivers. The fjords were especially good photographic material as the arms of the sea reaching into the mountains has helped to make Norway famous for beauty.

Bergen, the leading city of Norway, once the capital, and formerly the home of the Vikings, retains much of its old-world beauty and charm. It is famous the world over for its public fish market.

The trip was terminated by a few days spent in London. It was not foggy but extremely warm. The group sailed from Southhampton August 6, and arrived in Boston August 13. Fifty-six days were spent in Europe.

Listening Hour Audience Given Explanation

Editor, Daily Trojan:

In regard to yesterday's caustic comments on the management and the activities of the Trojan News Reel, during the Listening Hour, I would like to make a few explanatory remarks. My purpose is not to strike back sarcastically, or to fight any personal remarks directed at me, but to explain the reasons

why and for the activities which took place last Wednesday, January 12, 1938.

There seems to be a mistaken idea as to the type of publicity the News Reel involves. We do not try or attempt in any way to give a type of publicity that will fill an auditorium. When the Listening Hour was first announced, I realized that it was one of the better activities taking place on the campus, and as such deserves a place of high recognition in our film. Plans had been going on for at least a month and a half before Wednesday. Miss Alderman who is in charge of the Listening Hour expressed her willingness to cooperate with us; not only in the matter of filming during the Listening Hour but also in the writing of the script, of which Miss Alderman did play an important part. The story of the Listening Hour in its final out edition will be anything but pointless.

At this time we are not through shooting on the Listening Hour. We still have scenes to take of what goes on before it is presented in Bovard. As far as yesterday's disturbances are concerned, I do not want to apologize, but it is impossible to do work that we are doing without disturbing the people of whom we are taking pictures. The people who bothered to write in to the Trojan I feel, deserve an explanation of why we disturbed them, and I hope in the future that we will be able to circumvent similar inconveniences.

The cast of the picture includes Gloria Woods, Ben Marshall, and Poulson, Harrison's film records the habits of the "Least Tern," one of the birds of Southern California. Harrison leave Saturday morning on a cruise to Mexico and South America as photographer and collector for the San Diego museum.

I am not resigning as a political move or for any other reasons excepting this: Although I have never really neglected my studies for extra-curricular activities, I find that I greatly need the extra time which will be gained by this move to use in my preparation via the curriculum route for after-university life upon graduating in

I am not leaving the Lancer organization in the lurch as I know there are others entirely as capable as myself to fill the office I am vacating and ambitious to do so. At the next Lancer administrative board meeting I shall recommend an immediate election to fill my place and those of the two board members, Frances Dunn and Shirley Rothschild, who did not enroll in school this second semester. I wish to thank the many Lancer members and the Lancer administrative board for their fine cooperation in our activities this year. In looking back, I consider my administration a successful one, and consider it an honor to have seen the following things accomplished within the organization during this time:

(1) The enrollment of 300 new members during registration and membership drives.

(2) A successful social, service and athletic program.

(3) The very near completion of a thorough new constitution, which now requires only a few minor corrections and some sections yet to be passed by the board.

(4) The establishment of a new financial policy, under which all old debts have been wiped out and which has placed the organization on a sound financial basis with a treasury.

(5) Innovation of a membership card, of new activities, and of new ideas

As for campus politics, I participated in them because it was fun and valuable experience. To me, it is no longer fun and I consider I have had enough experience in it. However, I should like to state that I think it is inevitable that the nonorgs will come into power on this campus, and I know it can and will be done as it has at Stanford, U.C. Louis Tarleton, president of the Trojan Lancers and a member of many campus committees and organizations, resigned his Lancer position last night and announced also his complete withdrawal from all campus politics.

His resignation from the Lancers and withdrawal from campus political activities are due to the need for more time for his studies, Tarleton said, and are not to be construed as a political move.

LETTER TO EDITOR

In a letter to the editor which appears on page two of today's issue, Tarleton explains his reasons for resigning and the condition in which he has left the Lancer organization.

At the next Lancer administrative board meeting there will be a recommendation for an immediate election to fill the position vacated by farleton. There will also be an election to fill the positions left vacant by Frances Dunn and Shirley Rothschild, both of whom have not registered in school this semester.

PROGRESS MADE

During Tarleton's administration the Lancers have taken progressive strides toward a better organization. The membership has been increased by 300, a more efficient social, service, and athletic program has been established, and the organization is now functioning on a sound financial basis.

While active in campus political life, Tarleton served on nine ASUSC committees, was a senate member for three years, and was chairman of five ASUSC committees. He was also president of Delta Kappa Alpha, honorary cinema fraternity, member of Blue Key, producer of the Trojan newsreel, and freshman Bowen oratory cup finalist.

In closing, may I say that it has been a pleasure to serve the Lancer organization and the University of Southern California, and may I wish the best of luck to my successor, whoever it is.







May I first apologize for not having this design in your hands long before this date. It was buried among some other material on my desk and was entirely misplaced until this morning. I sincerely hope that this delay has not too greatly inconvenienced you.

You will note that we have included most of the symbols that you suggested when in the store, the masks for Dramatics, the camera for Cinematics, the art palette for Aesthetics, the torch for Honor, the open book for Education, and the lyre for Music. Any of these may be altered to other symbols that may come to your mind that would be more satisfactory than those that we have suggested.

It seemed to our artist that since you are having so much in the crest, the shield itself should be somewhat simple. It is probable that you may desire a little more mantling than is shown on the design. If this is the case, our artist will be glad to alter it carrying out any desires that you may have.

As to the price of the dies, our die cutter estimates that the cost would be \$12.00. Of this amount we are willing to assume half, the dies to remain our property and in our possession. You may at any time pay the other half and receive the dies, or you may pay the full \$12.00 at this time and receive the dies. The third proposition is that if you wish to pay your half of the die cost at this time, after \$25.00 worth of stationery has been purchased we will refund the \$6.00 which you have paid, the dies then to be our permanent possessions. Any one of these three plans is entirely satisfactory with us.

The cost of the membership certificates with the average amount of lettering in a size up to 6 x 8 would run \$12.50 for a quantity of fifty. Any size over the above mentioned size would
