Regarding your letter of October 1, 1956, we investigated the matter and verified the records at the bank. It was revealed that the National Chapter had an active account as late as March 23, 1954; on which date the balance \$12.29 was absorbed into the treasury of our chapter.

The bank statement, together with the cancelled items you transmitted, are enclosed for replacement in your files.

By this time you should also have received a check in the amount of \$44.00, which represents payment of dues for 64 active and pledge members for Fall 1955 and Spring 1956, as well as 24 members for Fall 1956. This determination is made on the basis of \$0.50 per active member per semester, or \$1.00 per member, per school year.
